## **FINDINGS**

The TORCH Antifa Network is an unincorporated national syndicate of anarchist extremist organizations and acts as the coalition's centralized networking hub and committee. It was created by the *Anti-Racist Action Network*, an organization with ties to known terrorists such as the *Weather Underground*. Membership chapters and affiliate groups have committed various crimes from assault, ethnic intimidation, vandalism, rioting, arson, stalking, harassment and conspiracy to violate human rights. This criminal racket is the largest anarcho-terrorist network in American, and is dedicated to the overthrow of the United States Government, which it perceives to be a "White Supremacist" state.

# HISTORY

Established in 2012, the TORCH Antifa Network is a rebranding of the *Anti-Racist Action Network*, originally founded in 1987.<sup>1</sup> The reason for the rebranding is unknown, though it is possible that the syndicate perceived fascism to be a definitionally broader category than racism. It is also possible that they were seeking solidarity and/or legitimacy from their European counterparts. Regardless of the reason, many of the chapters of the TORCH Antifa Network were present and highly active with the Anti-Racist Action Network years prior.

While the TORCH ANTIFA NETWORK should be seen as a continuation of the Anti-Racist Action Network, this report will not detail the actions and history of the parent syndicate, which may be the subject of another report. This report will focus on the history and action of the syndicate's chapters and affiliates from the time of its formation in 2012 to present.

During the organization's short tenure, the anarcho-terrorist gangs that comprise this criminal syndicate have left a trail of violence and mayhem in their wake. Chapters and affiliate groups have openly called for and successfully organized riots in California, Georgia, Oregon, Pennsylvania, Virginia and Washington D.C.. These events are detailed exhaustively below throughout the "chapters" and "affiliates section" of this report, and so will not be dealt with here.

In 2015, members of the *TORCH Antifa Network* assisted with the creation of a pro-terrorist documentary initially entitled *No Fascist USA*.<sup>2</sup> However, it is not clear if this documentary was ever finished. Although another documentary entitled *Antifa*, published by *Global Uprisings* may be the documentary referenced, since many of the syndicate's affiliate members field interviews throughout the film and it is now hosted on the syndicate's website.<sup>3</sup>

## IDEOLOGY

The TORCH Antifa Network has developed five “Points of Unity” (PoU) that membership chapters adhere to.<sup>4</sup> These are the five points as stated on their website:

1. **We disrupt fascist and far right organizing and activity.**
2. **We don’t rely on the cops or courts to do our work for us.** This doesn’t mean we never go to court, but the cops uphold white supremacy and the status quo. They attack us and everyone who resists oppression. We must rely on ourselves to protect ourselves and stop the fascists.
3. **We oppose all forms of oppression and exploitation.** We intend to do the hard work necessary to build a broad, strong movement of oppressed people centered on the working class against racism, sexism, nativism, anti-Semitism, Islamophobia, homophobia, transphobia, and discrimination against the disabled, the oldest, the youngest, and the most oppressed people. We support abortion rights and reproductive freedom. We want a classless, free society. We intend to win!
4. **We hold ourselves accountable personally and collectively to live up to our ideals and values.**
5. **We do not only support each other within the network, but we also support people outside the network who we believe have similar aims or principles.** An attack on one is an attack on all.

The TORCH Antifa Network’s PoU leave several ambiguities as well as reveal their commitment to morally rationalized political violence. Just who constitutes a “fascist” is unclear by the PoU alone, although law enforcement has been labeled as “fascist pigs” by the syndicate.<sup>5</sup> Point 1 therefore implies that (1) the government, and those who work for it, are considered fascists and (2) that the government is among their targets for “disruption,” not simply self-identifying fascists.

Another claim in the PoU is the opposition to “all forms of oppression and exploitation,” in which a host of -isms and “phobias” are listed: racism, sexism, nativism, anti-Semitism, Islamophobia, homophobia, transphobia, as well as ableism and ageism. However, the methodology used by *The TORCH Antifa Network* to determine who is “oppressed” or “exploited” is not revealed in any of their published works, and appears to be the result of a social convention among its members based

on identity grouping's real or perceived historical plight, socioeconomic outcome, social status, and institutional representation. Utilizing an intersectional heuristic, the gang attempts to apply the Marxist derived oppressed/oppressor dialectic to identity groupings and their outcomes. Far from being applied logically and consistently, the heuristic ensures that Whites, males, Christians and heterosexual individuals are always "oppressors," even if other demographics are economically more successful or overrepresented by media and corporate entities. This is revealing in that it demonstrates an intentional ignorance and rationalized targeting of specific identity groupings.

This very loose set of unifying factors in the PoU allows the syndicate's chapters an extremely high level of autonomy and protects from internal ideological schisms that would develop otherwise. The syndicate also emphasizes "security culture,"<sup>6</sup> and perceive themselves to be in a "three-way-fight" between themselves, the state, and White Supremacists. How the state can participate in this three-way-fight as both White Supremacist and at the same time against White Supremacists is never explained, and reveals a dissonance among adherents.

While commonly referred to as "Antifa" or "Anti-Fascists" by themselves and the general public, such organizations as the TORCH Antifa Network are designated as *Anarchist Extremists* by federal agencies such as the FBI and DHS.<sup>7,8</sup> Federal officials have distinguished between "Anti-fascism" and Anarchist Extremists claiming the former is an ideology while the latter is an individual or group who utilize violence to forward their goal of achieving an anti-state.<sup>9</sup> This distinction is also made by anarcho-terrorist intelligentsia who distinguish "liberal anti-fascism"

from “militant anti-fascism.”<sup>10</sup> The latter of which anarcho-terrorist author and Dartmouth lecturer Mark Bray<sup>11</sup> defined as “...an illiberal politics of social revolutionism applied to fighting the Far Right, not only literal fascists.”<sup>12</sup>

## TORCH ANTIFA NETWORK ANNUAL CONFERENCES

Once a year a chapter of the *TORCH Antifa Network* is chosen to host an annual conference. To date, there have been five official conferences held by the TORCH Antifa Network between 2014-2019. However, these conferences should be seen as an extension of the *Anti-Racist Action Network's* annual conferences, of which 18 are presumed to have been held from between 1994-2012. Two of the last conferences held by the Anti-Racist Action Network were held by the founding chapters of the TORCH Antifa Network and include the 16<sup>th</sup> annual conference hosted by *Rose City Antifa (RCA)* in 2009<sup>13</sup> and the 17<sup>th</sup> annual conference hosted by South Side Chicago Anti-Racist Action in 2010.<sup>14</sup>

However, only information for four of the Anti-Racist Action Network conferences have been located so far. These conferences are highly secretive with very little known about the event organizers or participants. A future report on the Anti-Racist Action Network may uncover more details about the parent group of the TORCH Antifa Network. In this report, we will only cover the TORCH Antifa Network Conferences.

### *1st Annual Conference (2014)*

The TORCH Network's first conference was hosted in Chicago, Illinois by *South Side Chicago ARA*. It was held at The Riverside Complex on September 13, 2014 and considered a success by the network. According to the gang, attendants of the

conference included delegates from *Philly Antifa*, *Central Texas ARA*, *Milwaukee Antifa*, *HARM*, *ARA LA/PART*, and the networks host, *South Side ARA*. According to the same source, other groups in attendance included *War Zone distro*, *Black Rose*, and the *IWW*. The conference also had a line-up of bands that included *Mandatory Abortions*, *La Armada*, *Krang*, *Wartorn*, *Wrathcobra*, and *ATU*. Other bands such as the *Appalachian Terror Unit* and *ARID* were slated to play, however, it is unknown if they showed up to the event. Known speakers included Matthew N. Lyons from *Three Way Fight* blog and Michael Staudenmaier author of *Truth and Revolution: A History of the Sojourner Truth Organization, 1969-1986* and member of the Four Star Anarchist Organization.<sup>15,16,17</sup>

### ***2nd Annual Conference (2015)***

The second annual conference was hosted in Philadelphia, Pennsylvania by *Philly Antifa*, with a private and public portion of the conference. Virtually nothing is known about the private portion of the conference, but according to an announcement of the event the public portion was held at an old church building owned by the University of Pennsylvania called *The Rotunda*.

The event included a talk entitled “Militant Anti-Fascism and the Black Lives Matter Movement.” In addition, the conference held a screening of the documentary “In Memory of Our Friend Ivan”<sup>18</sup> and a preview of what at the time was an unreleased documentary entitled “No Fascist USA.”<sup>19</sup> A concert was held in the evening with the band line up including *Christopher Walking*, *Leisure Muffin*, *Novotore*, and *Mischief Brew* whose leader singer, Erik Petersen, committed suicide in 2019.<sup>20</sup>

The Scranton chapter of the *Industrial Workers of the World (IWW)* provided security for the event. Delegates from *Antifa Philadelphia (Philly Antifa)*, *South Side Chicago Anti-Racist Action*, *Los Angeles People Against Racist Terror (PART)*/ *A.R.A.-L.A.*,

*NYC Antifa, Rocky Mountain Antifa, and Antifa International Collective* met for the private plenary where members made connections with Canadian anarcho-terrorists and discussed the *International Anti-Fascist Defense fund*.<sup>21</sup>

### ***3rd Annual Conference (2016)***

In 2016, Rocky Mountain Antifa hosted the TORCH Antifa Network's 3rd annual conference. The event was held November 11-12, with a private event held on Friday the 11th for the networks main chapters; Philly Antifa, WNC Antifa, Los Angeles Peoples Against Racist Terror (PART)/ARA-LA, and South Side Chicago ARA. On Saturday the 12th, a semi-public portion of the public was held and attended by groups and individuals from Denver, Philadelphia, Los Angeles, Ashford, Richmond, Dallas/Ft. Worth, Atlanta, Minneapolis, Portland, Chicago, and the Bay Area.<sup>22</sup>

Speakers were not named, but were said to have discussed a range of topics such as masculinity to counter-recruitment and prisoner organizing. The event was viewed as a success with "no disruptions from the enemy." In a review of the event by Rocky Mountain Antifa, a statement was published that called electoral politics useless and claimed that "fascists" such as Donald Trump had taken power. They further claimed they had been "smeared" by the liberal left for violently attacking participants at a nationalist rally in Sacramento in order to stop it from taking place. The Sacramento event almost turned deadly as a result when several of the 20 rally participants who were attacked by an armed lynch mob of 300 people, stabbed several of the anarcho-terrorists in self-defense.<sup>23</sup>

### ***4th Annual Conference (2017)***

South Side Chicago ARA claimed they would be hosting the 4th annual conference after attending the 2016 conference in Denver, Colorado.<sup>24</sup> However, no other information was discovered in our research. It is unknown at this time if the TORCH Antifa Network held a conference in 2017, although it is assumed so.

### ***5th Annual Conference (2018)***

The TORCH Network's fifth conference was hosted in Richmond, Virginia on September 1<sup>st</sup>-2<sup>nd</sup> by *Antifa Seven Hills*. It was held on September 1, 2018.<sup>25,26</sup> Details about the conference have since been deleted from the TORCH Antifa Network's Website, with no known archives of the webpage in existence.<sup>27</sup>

### ***6th Annual Conference (2019)?***

It is unknown if the TORCH Antifa Network held a conference in 2019, though highly possible that the event was never publicly announced.

## **CHAPTERS**

### ***Antifa Sacramento***

Antifa Sacramento is listed as a chapter of the TORCH Antifa Network.<sup>28</sup> In June of 2016, the gang organized a riot<sup>29,30</sup> with several other organizations<sup>31,32</sup> against the *Traditionalist Workers Party (TWP)* in Sacramento, California. When around 20 TWP members arrived, several hundred members of the black bloc instantly attacked them.<sup>33,34</sup> The anarcho-terrorists were so violent TWP rally-goers had to use near lethal force, stabbing five of the attackers, to defend themselves.<sup>35,36</sup>

During the riot, Antifa Sacramento and other anarcho-terrorists<sup>37</sup> armed with wooden clubs and other various lethal weapons chased down and assaulted a man filming the event, leaving him with blood streaming down his face.<sup>38,39</sup> The police stepped in when another man, begging for their help, was assaulted and then drug into the mob and beaten in front of law enforcement.<sup>40,41</sup> One man, attempting to walk away was smacked with a five-foot-long wooden stake as police arrived on the scene.<sup>42</sup>

Rally attendees were then hunted down and assaulted on the way to their vehicles, which were also attacked as they attempted to leave.<sup>43,44</sup> Law enforcement, on-the-ground journalists, and the Sacramento Antifa all claimed that the violence was initiated by the anarcho-terrorists.<sup>45,46,47,48,49</sup>

### ***Antifa Seven Hills (ASH Antifa)***

Antifa Seven Hills is a member of the TORCH Antifa Network and adheres to their points of unity.<sup>50</sup> In 2017, ASH Antifa signed a public statement calling on the public to disrupt the event.<sup>51</sup> Six members of ASH Antifa were arrested and charged with rioting during the 2017 presidential inauguration,<sup>52</sup> where black bloc participants lit a limousine on fire, threw rocks at police and local businesses, smashed the windows of storefronts and cars with crowbars and hammers, and assaulted innocent people.<sup>53</sup> As mentioned prior, the gang hosted the TORCH Antifa Network's 5th Annual Conference in Richmond, VA.

In 2017, a journalist was assaulted by ASH Antifa at a protest after refusing to stop filming when they demanded he quit. The journalist was taken by ambulance where he received four staples for a laceration to his head.<sup>54,55</sup> In a Facebook post about the incident, they went on to lie about what had actually taken place, claiming the journalist had "ran at them."<sup>56</sup> Video of the assault showed no such thing.<sup>57</sup>

### ***Ashville Anti-Racism***

This anarcho-terrorist gang participated in the rioting at Stone Mountain park in Georgia on April 23, 2016 with another TORCH Antifa Network chapter Atlanta Antifascists. The gang claimed that one of their comrades was arrested for violating the state's anti-masking laws. During the riot, they participated in storming the gates to the park and credited the lack of arrests by riot police to the presence of the Huey P. Newton Gun Club's armed members. When the police attempted to make arrests,

they were attacked by anarcho-terrorists who were actively aiding and abetting black bloc participants in violation of Georgia's anti-mask law.

Ashville Anti-Racism hailed the aiding and abetting of anarcho-terrorist criminals as “de-arrests” and proudly claimed that twice as many anarcho-terrorists were freed from police custody as were arrested.<sup>58</sup> They would go on to raise \$326 for the legal defense of one of the man arrested during the riot who was accused of throwing smoke bombs at police.<sup>59</sup>

A statement published by the TORCH Antifa Network claims the gang as a chapter of the syndicate and signer of a public statement denouncing legislation that would label “Antifa” gangs as domestic terrorist organizations.<sup>60</sup> Ashville Anti-Racism was also among the signers of the DisruptJ20 campaign to instigate riots at the presidential inauguration.<sup>61</sup>

### *Atlanta Antifascists*

On April 23, 2016, Atlanta Antifascists rioted at Stone Mountain park in Georgia along with several other gangs that included another chapter of the TORCH Antifa Network, Ashville Anti-Racism. They organized under a *post-hoc* front group called *All Out ATL* for the purpose of attacking a White Nationalist rally being held at the park. The Rose City Antifa chapter of the TORCH Antifa Network also endorsed the

action along with Atlanta Antifascist.<sup>62,63</sup> Members of the gang were identified at the event.<sup>64,65,66</sup>

During the riot, anarcho-terrorists shot fireworks and threw rocks at police, in addition to setting up barricades and lighting them on fire.<sup>67</sup> At one point a black bloc rioter threw a barricade at several police officers.<sup>68</sup> Eight black bloc participants were arrested for violating Georgia's anti-mask laws and a ninth was charged with aggravated assault.<sup>69</sup> During the day a sixty-nine-year-old man was also assaulted<sup>70</sup> and a vehicle was attacked.<sup>71,72</sup>

In September of 2017, an anarcho-terrorist suffering from gender dysphoria and a history suicidal behavior, Scout Schultz, was shot and killed by police at Georgia Tech.<sup>73</sup> Schultz called 911 claiming there was an individual with a knife and possibly gun on campus. When authorities arrived, Schultz screamed at the police to kill him while wielding a utility knife. When the police would not, he began moving towards

them until he was shot and killed. Three suicide notes were discovered in Schultz' dorm room.<sup>74</sup>

Atlanta Antifascists dropped several banners in solidarity with Schultz, one of which stated that "Scout wrecked shit and was down with punching Nazis."<sup>75</sup> Immediately after a vigil that was held on September 18, anarcho-terrorists rioted, violently attacking law enforcement and torched a police cruiser to the ground.<sup>76</sup> Atlanta Antifa celebrated, posting an image of a police vehicle on fire with the statements "NO APOLOGIES!" and "Rest in Power, #ScoutSchultz."<sup>77</sup> One officer suffered a head injury during the melee and was taken away in an ambulance.<sup>78</sup> Three individuals were arrested, two of whom were non-students charged with aggravated assault on an officer, which was not the first time such charges were brought against one of the men.<sup>79</sup>

### ***Central Texas ARA***

Central Texas ARA has yet to leave an impressionable impact as far as anarcho-terrorist cells go, let alone chapters of the TORCH Antifa Network. So far, their work has involved the doxing of members of nationalist organizations.<sup>80</sup> One of the doxes recently published was co-authored by *Screwston Antifascist Committee*,<sup>81</sup> another local anarcho-terrorist group that recently terrorized a man outside his suburban Houston home.<sup>82</sup> It is unknown if Central Texas ARA was there or how much their anarchist group overlaps with Screwston Antifascist Committee, though it is highly likely they were present and that the two groups coordinated actions.

## ***Northern California Anti-Racist Action (NoCARA)***

NoCARA was formed for the purpose of uniting various anarcho-terrorist groups in Northern California in 2016 to coordinate a riot against the *Traditionalist Workers Party (TWP)* at the State Capitol<sup>83</sup> with groups such as Antifa Sacramento mentioned previously and *By Any Means Necessary (BAMN)*. In an interview for a documentary called “Antifa” published by *Global Uprisings*, an individual with the gang who identified as “Lucy” claimed that the government wasn’t going to stop their opponents from holding rallies, but that didn’t stop anarcho-terrorists like NoCARA from shutting them down. “Lucy” went on to claim that anarcho-terrorist, who outnumbered TWP by 300 to 20, accomplished their goal of shutting down the rally but claimed that it came at a “high price,” referring to the anarcho-terrorists that were stabbed by various TWP members in self-defense from the murderous lynch-mob.<sup>84</sup>

In February of 2017, NoCARA organized a riot to shut down an event by the gay liberal Milo Yiannopoulos at UC Berkeley, along with BAMN and several other organizations.<sup>85</sup> Multiple attendees, several of them women, were violently attacked with wooden clubs and pepper spray by the anarcho-terrorist gang.<sup>86,87,88,89</sup> Multiple fires were started, that including a mobile light tower that had been knocked over by rioters.<sup>90,91,92</sup> The damage caused by the rioters was so extensive that it was estimated at \$100,000.<sup>93</sup>

## ***Pacific Northwest Antifascist Workers Collective (PNWAWC)***

On August 4, 2018, PNWAWC, along with Rose City Antifa and numerous other organizations, attempted to shut down a civic nationalist rally in Portland, Oregon.<sup>94,95</sup> During the rally, a Bernie Sanders supporter carrying an American flag was smashed over the head with a club by an anarcho-terrorist for refusing to let go of the flag as terrorist attempted to take it by force.<sup>96,97</sup> It took four staples to close the gash in his head.<sup>98</sup> Another anarcho-terrorist, Joseph Christian Evans, was arrested for shooting a high-powered wrist rocket slingshot.<sup>99,100</sup> He was later arrested for beating a man over the head with a metal rod at a rally in 2019.<sup>101</sup>

During the event, the black bloc was eventually ordered to disperse after police identified participants wielding weapons and warned that they would be subject to arrest or the use of riot control agents and impact weapons if they did not.<sup>102, 103</sup> Black Bloc participants refused, rioting and hurling glass bottles and other projectiles when law enforcement attempted to disperse their unlawful gathering. One journalist was left bleeding profusely after being smashed in the head with a bottle thrown by the anarcho-terrorists.<sup>104,105</sup>

The gang has also shared the names of spouses and home addresses of ICE employees on social media.<sup>106</sup>

After the death of anarcho-terrorist Sean “Armenios Lewis” Kealiher outside Cider Riot,<sup>107</sup> a popular anarcho-terrorist hangout, PNWAWC told their followers on twitter that his family asked that no one talk to the press.<sup>108</sup> PNWAWC went on to tell their followers not to “help the pigs build cases” and to “keep it in the community,” alluding to what sounds like a vigilante plot to take revenge on the killers.<sup>109</sup> Armenios was a known thug<sup>110</sup> who promoted explicit terrorist attacks on his blog, *Lumpen Prole Distro*.<sup>111,112</sup> In 2016 he was filmed threatening a man at a pro-Trump event.<sup>113</sup>

### ***Philly Antifa (Previously Philadelphia Anti-Racist Action)***

One of the earliest and most active chapters to join The TORCH Antifa Network was *Philly Antifa*, who signed on as early as December of 2013.<sup>114</sup> In 2007, three members of the organization (Jared Schultz, Tom Keenan, and Jason Robins) were arrested after smashing out the windows of an undercover police vehicle whose occupants they suspected were White Nationalists.<sup>115,116</sup> In 2011, Keenan was arrested with Joseph W. Alcott and charged with inciting a riot after attacking several participants

at a pro-White rally.<sup>117</sup> Keenan was arrested again during the J20 presidential inauguration riots in 2017 and was quoted in the *Washington Post* saying he thought “...there should have been more violence...” and that at future events, he would “...get to punch a Nazi” if the police didn’t stop him again.<sup>118</sup>

Thomas Massey was later arrested with fellow Philly Antifa member Tom Keenan and Democratic insider Joseph W. Alcott of *Smash Racism D.C.* in 2018. They were charged with the beating and ethnic intimidation of two United States Marines.<sup>119</sup> During the assault, Massey and Keenan, along with around ten other Antifa members who have yet to be charged, maced, punched, kicked and stomped the two men while calling them “Nazis” and “White Supremacists.” When one of the Marines, Alejandro Godinez, shouted that he was Hispanic, Alcott, Massey and Keenan began calling him a “spic” and “wetback.”<sup>120,121</sup>

Philly Antifa Hosted the second TORCH Antifa Network Conference in 2015, as previously mentioned.

### ***Rocky Mountain Antifa***

Rocky Mountain Antifa claim on their blog that they “...are active in the Torch Network and follow these [TORCH Network’s] points of unity.”<sup>122</sup> In 2017, an unidentified female member of the group wearing a t-shirt commemorating the *TORCH Antifa Network’s* annual conference hosted by *Rocky Mountain Antifa*, stalked and threatened a man leaving the *Denver March 4 Trump* rally. Wielding a

club poorly disguised as a flagpole, the woman approached the man she was threatening to fight only to be stopped by police.<sup>123</sup>

Another member of Rocky Mountain Antifa, Daniel Lovato, identified himself with the group on his YouTube channel by using the hashtag #RockyMountainAntifa in the title of several videos.<sup>124,125</sup> He was photographed by *The Denver Post* struggling with law enforcement officer personnel at a counter-Islamic rally in 2017 himself and other anarcho-terrorist rioted in an attempt to shut the event down. Lovato was arrested along with four others.<sup>126</sup>

Rocky Mountain Antifa was among the signers of the DisruptJ20 campaign to instigate riots at the presidential inauguration.<sup>127</sup>

### ***Rose City Antifa (RCA)***

Rose City Antifa is a particularly violent anarcho-terrorist organization currently listed on the TORCH Antifa Network's website as an active member.<sup>128,129</sup> At twelve years old, RCA is considered one of the oldest active "Antifa" organizations in America.<sup>130</sup> Its founders are claimed to be European expats.<sup>131</sup> RCA has conducted years-long terror campaigns in Portland and other places around Oregon against Christian and civic nationalist organizations.

RCA hosted Anti-Racist Action's 16th annual conference in 2010,<sup>132</sup> two years prior to the formation of the TORCH Antifa Network.

RCA has been highly vocal about their support for violence against nationalists or those they deem "far right." According to KATU, a local Oregon news station, the gang said that violence is "exactly what should happen when the far-right attempts to invade our town."<sup>133</sup> They have repeatedly made similar calls to violence in numerous other interviews.<sup>134,135</sup> In July of 2019, they claimed responsibility for the mob attack of journalist Andy Ngo that made national news and left the man with brain hemorrhaging.<sup>136,137</sup> In an interview with NBC's Dash Burns in August of 2019, RCA members reaffirmed their violent terrorist campaign in the Portland area.<sup>138</sup>

That same month RCA's organized a riot in Portland against the "End Domestic Terrorism" rally.<sup>139</sup> Anarcho-terrorists attacked a bus, along with numerous participants.<sup>140</sup> A Black man named Jamal Williams, who participated in the black bloc, threatened journalists and other individuals at the event. He was arrested on hate crime charges several weeks later after repeatedly threatening to kill several Jewish men.<sup>141</sup>

In 2019 when local Portland anarcho-terrorist Sean Kealiher was killed in mysterious circumstances outside the local anarcho-terrorist Cider Riot headquarters, RCA mourned his death on twitter.<sup>142</sup> Kealiher was well documented for his bullying activity and targeted harassment of political opponents, some of which was documented by journalist Andy Ngo when he was first getting his start.<sup>143</sup>

### **South Side Chicago Anti-Racist Action (ARA)**

The South Side Chicago ARA chapter of the TORCH Antifa Network is unique compared to other chapters in that they like to brag about the violent assaults their gang members commit. As far back as 2010, they claimed they used a u-lock to assault several White advocates during a violent anti-White terrorist attack.<sup>144</sup> In 2012 they bragged about their comrades vandalizing a monument in Chicago.<sup>145</sup> In 2013, they lead a fundraiser for the Tinley Park terrorists that raised \$500.<sup>146</sup>

More recently, in February of 2017, the gang bragged about using bear mace on several nationalists in the parking lot of a bar as they were leaving.<sup>147</sup> In May of the same year, they published an article celebrating how several of their members sent a man to the hospital in an ambulance after beating him with cue sticks at a bar, making additional threats to him in the article.<sup>148</sup> Later that same month they published another article bragging about their associates breaking the hand of a man at a bar in Madison, Wisconsin after stalking him to his car.<sup>149</sup> That summer they bragged about assaulting participants of the Charlottesville Unite the Right Rally.<sup>150</sup> It is no surprise

that, as with all anarcho-terrorist organizations, the group explicitly claims to “reject the concept of constitutional free speech.”<sup>151</sup>

The gang was instrumental in the creation of the TORCH Antifa Network. In 2011, the gang hosted the 17<sup>th</sup> annual Anti-Racist Action Conference, which had anarcho-terrorist Bernadine Dohrn of the *Weather Underground* as a guest speaker.<sup>152</sup> Several years later the gang hosted the 1<sup>st</sup> annual TORCH Antifa Network conference in 2014, and claimed they would be hosting the 4<sup>th</sup> in 2017.<sup>153</sup>

## OTHER AFFILIATIONS

### *Coalition to Defend Affirmative Action, Integration and immigration rights and fight for equality By Any Means Necessary (B.A.M.N.)*

A request under the Freedom of Information Act (FOIA) by *Property of the People* revealed that By Any Means Necessary (BAMN) was investigated by the FBI as a potential terrorist organization after one of its members assaulted a man at a rally they organized a riot to stop<sup>154</sup> with Sacramento Antifa and Northern California Anti-Racist Action (NoCARA) at the state capitol in 2016.<sup>155,156</sup> While redacting the name of the individual, it is likely the person in question was one of the organization’s leaders, Yvette Felarca. Video that day caught Felarca punching a man with his hands raised begging the cops to intervene.<sup>157</sup> Felarca faced charges for assault, rioting, and

inciting a riot for her role in the event<sup>158</sup> She was arrested again at another event in Berkeley in September 2017 and charged with battery and resisting arrest.<sup>159</sup>

Felarca admitted on national television to organizing another riot to stop a gay liberal speaker, Milo Yiannopoulos, from giving a speech at UC Berkeley.<sup>160,161</sup> Multiple attendees, many of them women, were violently assaulted with clubs and pepper spray by the anarcho-terrorist mob.<sup>162,163,164,165</sup> The damage caused by the riot was estimated at \$100,000.<sup>166</sup>

In 2018 Felarca was successfully sued by Troy Warden, a former president of the Berkeley College Republicans, after filing a baseless restraining order against him<sup>167</sup> and in 2019 was ordered to pay the legal fees of Judicial Watch after filing a frivolous lawsuit in a failed attempt to keep her records with the Berkeley Unified School District private.<sup>168</sup> Despite the violence she herself has committed and instigated, she continues to work as an elementary schoolteacher.

### ***Great Lakes Antifa (GLA)***

Great Lakes Antifa was excommunicated from the syndicate following the publishing of a statement signed by numerous chapters and affiliate groups. A statement regarding the affair was published on the TORCH Antifa Website in April of 2018.<sup>169</sup> In addition, a website was created a month prior where individuals were warned to stay away from GLA and made multiple claims against the gang. Both the statement and the website claimed that the gang “physically attacked a woman of color.... while also using sexist slurs.” In addition, it was claimed that the gang posted video online exposing their members and spreading false information.<sup>170</sup> Several opposition websites documented the drama.<sup>171,172</sup>

### ***Hoosier Anti-Racist Movement (HARM)***

HARM is best known for the Tinley Park terrorist attack of 2012. During the attack 18 members and associates of the gang rushed into a restaurant masked and armed with baseball bats, batons, and hammers and attacked a small group called the European Heritage Association who were meeting over lunch to discuss topics a program to help poor White Americans find work.<sup>173</sup>

During the anti-White terrorist attack, the anarcho-terrorists assaulted several patrons as well as the restaurant owner who attempted to stop them. Five members of the gang were pulled over and arrested as they fled the scene and received various sentences for their participation ranging from 3 to 6 years.<sup>174</sup> The identities of the other twelve participants were never uncovered.

HARM attended the first TORCH Antifa Network conference (as mentioned previously) and received financial and moral support from several chapters who knew they were guilty. This includes Philly ARA, Rose City Antifa, and South Side Chicago ARA.<sup>175</sup> Philly ARA celebrated the attack saying that they “would like to salute whoever was responsible for this successful action.”<sup>176</sup> South Side Chicago ARA called for their comrades to pack the courtroom at a court appearance for the gang<sup>177</sup> and all three chapters fundraised for HARM’s legal expenses.<sup>178,179,180,181</sup>

### ***It’s Going Down***

*It’s Going Down (IDG)* is an online anarcho-terrorist publication. Contributors to the site have bragged about rioting and attacking political opponents.<sup>182</sup> The publication has repeatedly published communiques and articles from terror cells publicizing acts

of sabotage<sup>183,184,185,186</sup> and violent assaults.<sup>187,188</sup> These violent exploits include articles from every chapter of the anarcho-terrorist syndicate.<sup>189,190,191,192,193,194,195,196,197,198,199,200</sup> Collectively TORCH Antifa Network chapters have contributed as many as 104 articles to the website.

The *John Brown Gun Club* is a communist paramilitary organization. In May of 2019, a member of the *Puget Sound* chapter of the club was charged with felony harassment after stalking a member of the *American Identity Movement (AIM)* outside his home while brandishing a pistol in Seattle, Washington.<sup>201</sup> Several months later another member of the same chapter, Willem van Spronsen, attacked a federal ICE facility. During the attack Spronsen carried what appeared to be a rifle while firebombing a federal vehicle and attempted to ignite an industrial sized propane tank. He was shot dead at the scene.<sup>202</sup> The TORCH Antifa Network proudly republished his manifesto on their website.<sup>203</sup> The *Puget Sound*, *Mid Missouri* and *Truckee Meadows* chapters of the *John Brown Gun Club* have all signed a position statement the organizations published.<sup>204</sup>

### ***Revolutionary Abolitionist Movement (RAM)***

The Revolutionary Abolitionist movement has signed a position statement published by the TORCH Antifa Network,<sup>205</sup> and has attended multiple events promoted by the syndicate’s chapters. RAM is far more explicit in their use of tactics than many other organizations. According to their own manifesto “revolutionary justice may just as easily be called self-defense.”<sup>206</sup> The examples of “revolutionary justice” provided by RAM in their manifesto are that of terrorist organizations that have committed numerous counts of murder.

*“every group that goes underground to launch clandestine attacks against bondage and oppression, like the Black Liberation Army or the United Freedom Front\*\*\*, engages in acts of revolutionary justice.”<sup>207</sup>*

“Self-defense” for RAM is therefore not defensive violence to protect oneself from immediate corporal injury, but instigative violence used in pursuit of their anarchic agendas. The anarchist publication *It’s Going Down*, as mentioned above, has extensive ties to the TORCH Antifa Network and hosts RAM’s manifesto at the top of its online library webpage.<sup>208</sup> This implies that the syndicate approves of RAM’s own position on the use of terrorism. *The William McKinley Institute’s* in-depth report on RAM details the full history of the organization and its activities.<sup>209</sup>

### ***Smash Racism DC***

In 2017, one of the co-founders of the gang, Mike Isaacson, was caught by an undercover journalist planning to shut down the D.C. Metro during the presidential inauguration with several other anarcho-terrorist organizations. It was revealed by one of the plotters that they were planning on using chains to keep the trains from leaving the station.<sup>210</sup> Isaacson was later placed on administrative leave from his job as an adjunct professor at John Jay College of Criminal Justice after claiming on social media that he thought it was “a privilege to teach future dead cops.”<sup>211</sup> The college later claimed that he no longer worked for them.<sup>212</sup>

Isaacson would go on to state on national television in an interview with Tucker Carlson that he believed in committing violence against his political opponents.<sup>213</sup> Eight months later, members of his gang showed up outside Fox News host Tucker Carlson’s house in an intimidation attempt.<sup>214</sup> During the incident the anarcho-terrorist cell chanted “Tucker Carlson, we will fight! We know where you sleep at

night!.”<sup>215</sup> They also banged on his front door and spray painted the circle-a anarcho-terror symbol on his driveway.<sup>216,217</sup> During the incident Carlson’s terrified wife locked herself in the pantry and called police.<sup>218</sup> The DC police investigated the incident as a hate crime, but no arrests were ever made.<sup>219</sup>

As with the chapters of the TORCH Antifa Network, Smash Racism DC is also an author at *It’s Going Down*.<sup>220</sup> As mentioned previously, Joseph Alcott, a member of Smash Racism DC was arrested and charged with several assaults, both with members of the TORCH Antifa Network’s Philly Antifa chapter.

### ***The International Anti-Fascist Defence Fund***

This anarcho-terrorist fundraising organization proudly proclaims that it was endorsed by the TORCH Antifa Network<sup>221</sup> and claims to be “an international fund run by over 400 anti-fascists in seventeen different countries.”<sup>222</sup> The organization has raised funds for multiple anarcho-terrorists in countries around the world.

In 2016 they helped raise money for the parole of Jason Hammond of the Tinley Park Terrorists (mentioned previously) after he was released from serving a three-and-a-half-year sentence for his role in a terrorist attack in a restaurant in 2012 that left multiple people injured.<sup>223</sup> In 2017 they donated funds for the presidential inauguration black bloc rioters, also known as the J20 defendants, who caused an

estimated \$100,000 worth of damage.<sup>224,225</sup> In 2018 and 2019 they raised funds for David Campbell,<sup>226</sup> a 32 year-old anarcho-terrorist who attacked a 56-year-old man in New York.<sup>227</sup>

Dartmouth lecturer and anarcho-terrorist supporter Mark Brey claimed to have donated at least 50% of his book sales from *Antifa: The Antifascist Handbook* to the terrorist funding organization.<sup>228</sup>

Organizations on this list are not necessarily still in existence or in good standing with the syndicate. For example, Great Lakes Antifa, listed above, was excommunicated from the syndicate in April of 2018 after the publishing of a joint statement by the group.<sup>236</sup> However, all organizations listed above have at one

## **CONCLUSION**

The TORCH Antifa Network is currently the greatest threat to liberty in the Republic. The syndicate has consistently called for and violated the constitutional rights of American citizens and attacked American military personnel. Failure by the United States government to act in the protection of its citizens will undermine the state's legitimacy, and citizens will begin looking to alternative groups to pledge their allegiance, thereby creating a national crisis.

Prior to this report, chapters of the TORCH Antifa Network have been treated as entirely distinct organizations without national ties to other anarcho-terrorist groups through an over-arching criminal syndicate. This level of higher order coordination is incredibly significant and makes these groups far more dangerous, as their resource pool is much greater than may initially appear. The level of technical and strategic experience its leadership has is vast and the network's past has been traced far beyond its recent rebranding to anarcho-terrorist groups with clandestine experience like the Weather Underground and decades of organized targeted rioting and harassment campaigns through Anti-Racist Action Network.

Further efforts should be made by journalists to uncover and expose the leadership of this network. The William McKinley Institute recommends that journalists covering anarchist and equalitarian extremism highlight the connection in future media coverage of TORCH Antifa Network chapters and affiliate groups. Furthermore, journalists should habituate themselves to properly classifying such groups as anarcho-terrorists as opposed to the euphemistic self-identification of "anti-fascist." This term is used by anarcho-terrorists to confuse the public as to who they are, what

they themselves advocate (anarchism/communism), and how they intend to overthrow the United States government — that they perceive as a White Supremacist state — through violence.

State and federal authorities are advised to forward legislation labeling this syndicate and its subsidiary chapters and affiliate groups criminal gangs. Furthermore, a RICO investigation should be opened into the TORCH Antifa Network by federal authorities. Senator Ted Cruz has already called for such an investigation into “Antifa” that was brushed aside by FBI Director Christopher Wray who claimed Antifa was an ideology, not a group. The director went on to explain that the FBI did have a category of “anarchist extremists” and that a number of smaller inquiries were underway.<sup>237</sup> Senator Cruz and others should approach FBI officials again to specifically ask for an investigation into the TORCH Antifa Network, providing them this report along with their request.

Organizations or individuals who have been targeted by this syndicate should file a report with authorities and seek legal counsel. There are countless examples of the TORCH Antifa Network actively conspiring to violate the rights of individuals and identity groups. Litigation against the network may at this time be the best way to not only receive justice for victims, but also to prevent future victimization from occurring.

Members of the public should ensure that their local and state authorities are aware of the existence of such groups operating in their jurisdiction. Law enforcement should be informed when contact is made with members of the syndicate. Individuals should not attempt to intervene when such groups are conducting illicit activity, but providing law enforcement with documented evidence if possible is highly advised.

Former associates of the TORCH Antifa Network and its affiliates are encouraged to come forward with information about the network and its leadership. Exposing syndicate plans and leaders will de-escalate the rapidly escalating political violence in America.
